- ALL submissions MUST be received via the Elsevier Editorial System (EES) electronic submission site. For details see http://ees.elsevier.com/diamond
- Deadline for receipt of manuscripts to be assured for consideration for the Diamond 2009 Proceedings Volume: Saturday 02 AUGUST 2009 via the Elsevier Editorial System (EES).
- 3. Only contributions PRESENTED by the author(s) at the Conference will be considered for publication in the Proceedings Volume.
- 4. Submission implies that the manuscript is not under consideration for publication elsewhere and that, with the exception of review papers, the manuscript represents original work not previously published.
- 5. All manuscripts will be reviewed following the editorial procedures of Diamond and Related Materials.

After you have registered via EES (REGISTER ONLY ONCE; select 'change details' to update your registration), choose Submit New Manuscript from your Author Homepage menu.

'Title': enter the title of the manuscript.

'Article Type': 'Special Issue: Diamond 2009'.

'Add/Edit/Remove Authors': If you are the corresponding author, do NOT re-enter your personal information. It will already appear on this page. Enter the First (GIVEN) Name and Last (FAMILY) Name of the CORRESPONDING Author as well as the other requested information AND check the 'Please select if this is the corresponding author' box. Select 'Add Author'. Enter the information for EACH additional author, but do NOT check the box indicating the Corresponding Author for these authors. Use the arrows to place the list of authors in the correct order as found in the manuscript.

'Select Section/Category': 'Diamond 2009'.

'Select Classifications': select <u>ONLY FOUR</u> of the <u>Classifications</u> which appear in the <u>list</u>. These <u>SAME FOUR</u> <u>Classifications</u> should <u>also</u> appear on the <u>REQUIRED Prime Novelty Statement Page</u>. You <u>MUST</u> choose <u>one to four</u> classifications.

Answer the four 'Additional Information' questions found on the next page. A simple 'YES' or 'NO' is the requested response to the first three questions. Enter the REFERENCE NUMBER as the response to the fourth question, for *example*, DIAM2009_0001 or DIAM2009_0585 ...etc. INVITED Presentations will have a REFERENCE NUMBER such as DIAM2009_IS01 or DIAM2009_IS35.

'Enter Comments': enter the **REFERENCE NUMBER** and any other comments the authors would like to make to the editor. 'Request Editor', choose 'No Request'.

'Attach Files': upload the **REQUIRED Prime Novelty Statement Page** as a WORD (.doc) -compatible manuscript file (<u>NOT</u> a PDF). Upload figures and tables separately in TIFF, EPS, MS Word, Powerpoint or Excel format.
